

Dear Parents and Guardians:

North Junior High School is having its annual fund drive. This does not require your student to participate in bake sales or to sell items door to door. All that is involved is a simple donation to the Boise Public Schools Education Foundation. Donations to the Foundation are tax deductible and are eligible for the tax credit for contributions to Idaho educational entities. Some of your employers even match your contributions to the Foundation.

Any contribution earmarked "North Junior High School" goes to help students, programs, teachers, and/or improve the school facilities here at North. Contributions can be specified for music programs, class teams, 9th grade Freshman Farewell or school improvements. Examples of your dollars at work might be new classroom computers, new curtains for the stage, white boards for classrooms, and new drinking fountains. **Our goal is to decrease the amount of requests your student makes for money on behalf of school activities and to get the most benefit for the money you invest in your student's school.**

When you donate \$100 by check, all of that money goes to programs that you specify; none of that money is used for record keeping or handling fees. In addition, your actual costs after taxes are a fraction of your donation. For example, if you donate \$100 to the Foundation for North Junior High School, typical out-of-pocket expense after taxes will be approximately \$19. A \$200 contribution will result in a typical \$39 after-tax expense and a \$500 donation will typically cost only \$146 after tax breaks.

Remember, donations to North Junior High School through the Boise Public Schools Education Foundation are tax deductible. The Foundation accepts checks, MasterCard, Visa, and new this year, online donations through pay pal. We see this opportunity as one that will mutually benefit you and your child's school.
