Waiver, Release of Liability, and Assumption of Risk

This is a Waiver, Release of Liability, and Assumption of Risk associated with the Timberline High School Class of 2010 All-Night Graduation Party to be held at Thunder Mountain Railroad Line in HorseShoe Bend Idaho on May 27, 2010. You and your parent(s) or guardian(s) must sign this if you want to attend and participate in the party. The intent of this agreement is to explain the rules regarding the party and to protect the Timberline Parents Organization (TPO) from liability associated with your attendance and participation. You an your parent(s) or guardian(s) agree to the following:

1. You acknowledge that you are sufficiently healthy and capable of determining which activities you can participate in and assume all risk of injury due to your attendance and participation.
2. You acknowledge that this is a drug and alcohol free party. If you are under the influence of drugs or alcohol or use of drugs or alcohol while at the party, you will be detained while a resource officer or police are contacted. Your parents will also be notified.
3. You agree to waive, release, discharge and forego any and all claims of any type against the TPO and assume all risks related directly or indirectly to your attendance and participation. You further agree to hold harmless an indemnify the TPO from any claims whether brought by you or a third party due to your attendance and participation. "TPO" includes the organization, its officers, agents, representatives, volunteers, or anyone else helping the TPO with this party. Claims include, but are not limited to, claims for injury death, disability, sickness, disease, or damage to personal property whether caused by the actions, inactions, or negligence of the TPO and where brought by you, your heirs, assigns, representatives, insurers or relatives.
4. You further agree that the TPO is not responsible for the lost or stolen items and that you are responsible for the care of your personal property.
5. You agree that you will be held responsible for any damages or vandalism caused by you.
6. You agree that rude, violent, or other objectionable behavior is prohibited and that you will be required to leave the party if you engage in such behavior.
7. You acknowledge that you are a representative of Timberline High School and agree to conduct yourself so as to not damage the reputation of or cause embarrassment to Timberline High School or your fellow classmates.
